DCV Volunteer Services in the era of COVID19

Revised Services for Dupont Circle Village effective May 29, 2020

Background:

In March, DCV adopted a policy to suspend volunteer services that:

- require face to face contact with a member or
- require the volunteer to engage in activities outside of their homes such as grocery shopping

Some member services are occurring utilizing commercial services that are set up with assistance from DCV. These include transportation via Go-Go Grandparent, grocery deliveries via Instacart, nutritional supplements via Amazon, and pharmacy delivery of medication.

Support for members also continues through check-up calls to members via other members. This has netted information for follow-up services such as frequent check-in calls, and food deliveries, some paid for by DCV. Our case manager has continued to provide support for our members needing her services.

The DCV COVID19 working group has met to assess the current situation and has made recommended changes to the Board.

Changes in the operation of essential services (grocery shopping, medication pickup) have made it substantially safer for people to shop while adhering to COVID19 guidelines for social distancing. The working group has reviewed the following DCV services offered and has evaluated the probable risk to DCV volunteers providing and DCV members receiving a service. Recommended instructions outlining safety guidance for volunteers during shopping and delivery will be sent to all volunteers who offer services. (Appended)

Based on this review, the DCV Board has approved the Volunteer service guidelines effective with the District of Columbia's implementation of Phase I Guidelines, on Friday, May 29, 2020.
